Luther Crest Bible Camp Glow Trail Run Waiver and Release

Important Information

Luther Crest Bible Camp is committed to providing participants with programs and activities in a safe manner and holds the safety of participants in the highest regard. Luther Crest continually strives to reduce such risks and insists all participants follow safety rules and instructions designed to protect participants' safety. However, participants and parents/guardians must recognize that there is an inherent risk of injury when choosing to participate in the 2016 Glow Trail Run.

Assumption of Risk:

The Glow Trail Run takes place on the Luther Crest trails at night. Even with careful trail maintenance and trail marking, these trails are in a wooded area with curves, bumps and tree roots. Even with lights placed throughout the trails, there are still areas where it can be quite dark. Luther Crest has staff and volunteers placed throughout the trails with flashlights to help guide all participants. Luther Crest has several water stations placed throughout the trails to help participants remain hydrated at all times. Luther Crest has a trained Health Care Manager monitoring the participants and providing any first aid as needed.

Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of injury. Understandably, not all hazards and dangers associated with the Glow Trail Run can be foreseen and it must be recognized that it is impossible for Luther Crest Bible Camp to guarantee absolute safety.

I recognize and acknowledge that there are certain risks of physical injury to participants in the Glow Trail Run and I voluntarily agree to assume the full risk of any injuries, damages, or loss regardless of severity that I or my child may sustain as a result of participating in any and all activities connected with the event.

Waiver and Release of Liability and Claims:

By signing this waiver, I agree to defend, indemnify, and hold Luther Crest, their officers, directors, officials, employees, volunteers, and agents harmless against any and all liability, loss, expense, including reasonable attorney's fees, or claims for injury or damages arising out of my or my child's participation in the Luther Crest Glow Trail Run.
